Wife One feather bed Two pair of Sheets and all the furniture of the room or Chamber wherein I  
usually ly<sup>e</sup> Except the Hanging Presse ther<sup>t</sup> but not the Linen or other things that may be contained in  
the Chests or other furniture ther<sup>t</sup> Item my mind and will is that my said Wife and my son Daniel  
Gutteridge do Manage and Carry on the Farming and Husbandly busyness, and the redendum of my personal  
Effects and herew<sup>t</sup> the Rents of the Mesuages herew<sup>t</sup> devised until my said Son Daniel shall attaine his  
Age of One and Twenty years, for his better Maintenancē and providing of my said Wife  
and all my said Children that are now in their Minority, And my Will is that so long, and for such  
time as my said wife shall be so Maintained out of my said Estate as aforesaid, That she shall  
not have or receive any Rent for the land so given to her for life as aforesaid, any thing  
received contrarye thereto notwithstanding but that the same shall be Occupied and  
employed for the same uses as my said personal Effects is above mentioned to be Managed for all my  
partner Will and desir<sup>e</sup> is, That my said wife, do live with and assist my said Son Daniel after he  
shall attaine his said Age, in carrying on the Farming and Husbandly busyness so long as my said  
Son Daniel shall live a single life, if his my said Wife shall so long live and remaine my Widow  
& they shall truch most so to do Item I do will and Appoint that from and after my said Son  
Daniel shall have attaine<sup>d</sup> his said Age, The interest of the respective Legaries of my said Children  
that shall be then in their Minorities, shall be respectively paid and Applied to and for the respective  
Maintenancē and Support of the respective Legatees until the same shall respectively become  
payable Item I do hereby Appoint and devise the respective Guardianship and Tuition of all my  
said Children now in their Minorities unto Elizabeth my said Wife until they shall severally and  
respectively attaine his Age of One and Twenty years if his my said wife shall so long live and  
continue my Widow but if she shall happen to dye during his said Term or be Marryed (which  
shall first happen) Then in either of the said cases, my Will is and I do Appoint my said Sons  
Matthew and Richard Gutteridge and the Survivor of them Guardians in stead of my said wife Item
